I authorize my child(ren) to travel in a bus, plane, rental car, etc. with Calvary Bible Church of Grass Valley, California. I understand and agree that the vehicle in which the above named child(red) may be traveling may not be owned by Calvary Bible Church. I am familiar with the dangers associated with vehicular transportation and understand that accidents are common. I also understand that the consequences of vehicular collisions include serious injuries, which may be permanent and can even result in death.

I also understand that during the trip, my child(ren) may participate in various activities including but not limited to, riding in a car, skiing, snow boarding, playing in the snow, playing games etc., and other activities associated with winter. I understand that such activities involve inherent and other risks of injury and death.

I understand that participation in each activity and event involves inherent and other risks. In consideration for the participant(s) being permitted to be involved in the activities and events during the calendar year 2025, I agree to release Calvary Bible Church and its pastors, elders, officers, staff, employees, volunteer workers, attorneys, agents, representatives, affiliates, successors-in-interest, and assigns (collectively "Providers") from all liability, in excess of the applicable limits of any insurance providing coverage to Providers, for injury, death, and property loss and damage that arises out of or results from the activities and events, including all liability which results from the *negligence* of Providers, or any other person or cause.

I agree to submit any claim or dispute that arises out of, or results from any activity or event or this agreement to mediation and, if mediation is not successful, to legally binding arbitration. The mediation and legally binding arbitration will be conducted in accordance with the *Rules of Procedure for Christian Conciliation* of the Institute for Christian Conciliation. Judgment upon an arbitration award may be entered in any court otherwise having jurisdiction.

Additionally, we recognize there are cultural differences with regard to gender and identity in this world, however our policy regarding sexuality and gender identity is grounded in the historically traditional understanding of Christian sexuality, which is rooted in the Bible (Genesis 1:27). Therefore we will have all students participate with their biological gender when it comes to gender divided activities. This includes, but is not limited to, assigned sleeping arrangements, bathroom use, small groups, appropriate dress, etc.

This agreement is binding upon the participant's heirs, executors, administrators, and assigns. I acknowledge this agreement is governed by the applicable laws of the State of California. If any provision of this agreement is held in whole or in part to be unenforceable for any reason, the remainder of that provision and of the entire agreement will be severable and remain in effect.

**Winter Sports Activities Release of Liability and Indemnity Agreement  
READ CAREFULLY BEFORE SIGNING – THIS LIMITS DONNER SKI RANCH LIABILITY**

I, \_\_\_\_\_, or my child (collectively referred to as "I", "my", or "me") have voluntarily applied to participate in winter sports activities and other recreational activities at Donner Ski Ranch, including but not limited to, skiing, snowboarding, snowtubing, sledding, all other winter sports or related activities, and all activities at Donner Ski Ranch Ski Hill, and Donner Ski Ranch Tubing Hill. I understand that my participation in the sport poses risks of INJURY and DEATH. The risks include, but are not limited to, loss of control, collisions with other skiers, snowboarders, or tubers, collisions with natural and man-made objects, including trees, rocks, fences, lift towers, snow making equipment, and over-snow vehicles. The risks also include variations in terrain and snow conditions, surface and subsurface snow conditions, bare spots, bumps, moguls, ice, stumps, forest growth and debris, erosion control devices, rocks, cliffs, steep terrain, avalanches, and traveling in the mountains and beyond the ski area boundary. Other risks include those associated with the use of the facilities, including mountain transportation, lifts, terrain parks (jumps, rails, boxes, half pipes, and other park features), slope style, skier/boarder-cross, performing maneuvers (inverted or otherwise), walking in lodges and parking lots, and participating in lessons, races, tubing, sledding, and special events (collectively, "use of the facilities"). Despite these risks and all other risks, and **TO THE FULLEST EXTENT ALLOWED BY LAW, I AGREE TO EXPRESSLY ASSUME ALL RISKS OF INJURY OR DEATH** that might be associated with or arise out of my participation in the sport or use of the facilities.

I understand that if I enter a terrain park, I must inspect the elements and terrain before I ski or ride over them to evaluate the risks and degree of difficulty before participating. I understand that throughout the day snow conditions and terrain features will change. I am solely responsible for knowing and understanding my ability to encounter all terrain features.

In consideration for being permitted to participate in the sport and to use the facilities, **I AGREE TO RELEASE FROM ANY LEGAL LIABILITY AND AGREE NEVER TO SUE DONNER SUMMIT RESORTS, LLC**

dba DONNER SKI RANCH or any of their parent companies, subsidiaries, owners, employees, agents, landowners, or The United States of America Department of Agriculture, Forest Service (collectively, "Donner Ski Ranch") for injury or death resulting from my participation in the sport or use of the facilities, regardless of the cause, including the alleged **NEGLIGENCE** of Donner Ski Ranch. I further **AGREE TO DEFEND, INDEMNIFY AND HOLD HARMLESS** Donner Ski Ranch for any claims, lawsuits, damages, attorney fees, costs or judgments arising out of my participation or my child's participation in the sport or use of the facilities.

I UNDERSTAND THIS IS A RELEASE OF LIABILITY THAT IS VALID FOREVER, and will apply whenever I participate in the sport or use the facilities at Donner Ski Ranch. I understand that this RELEASE OF LIABILITY will prevent me, my child, or my heirs from filing suit or making any claim for damages in the event of injury or death from my participation in the sport or use of the facilities.

Additionally, in the event I file or my child or any legal representative files a claim or a lawsuit arising out of my participation in the sport or the use of the facilities at Donner Ski Ranch, I AGREE TO DEFEND, INDEMNIFY AND HOLD HARMLESS Donner Ski Ranch for any damages, attorney's fees, or costs arising out of such a claim or a lawsuit. With a full understanding of this agreement, I nevertheless enter into this agreement freely and voluntarily and agree that it is binding upon me, my child, my heirs, assigns and legal representatives.

I understand and agree that this agreement is severable and that if any clause is found to be invalid, the balance of the contract will remain in effect and will be valid and enforceable. I agree that any action will be brought in the County of Nevada, State of California, or alternatively, in a court of competent jurisdiction in the State of California. Any disputes will be subject to and determined under the laws of the State of California.

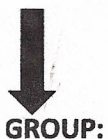
